The **General Data Protection Regulations** will replace the current Data Protection Act from next May 2018. These new regulations will place greater responsibility on organisations (including schools) on the safety and security of data.

The workshop will focus on helping schools gain a better understanding of the changes in legislation, the implications if the regulations have not been followed, what schools have to do to be compliant and how to go about it. A number of practical resources will be included as part of the course.

### Latest features in RM Integris

#### Following the latest upgrade, here's a reminder of the most useful features.....

In our last issue this term, we alerted you to the significant changes in how Pupil Premium can be recorded and searched for - if you haven't read about this or received our first Newsletter for the year, you can access all our newsletters from the RMIntegris Home/Newsletters menu link on our website <a href="https://www.cbict.org.uk">www.cbict.org.uk</a>.

Adjust the automatic Logout timings ... following many requests to change the automatic time out facility, administrators can now change the length of time before users are logged out of RM Integris from the current default of 45 minutes. All it requires is for the Administrator to go to System Management > Preferences > Security tab > Edit > enter the number of minutes (to a maximum of 120) and click OK. This auto logout time will apply to all users who logon after the change is made. Note: please advise users who make changes to data to keep saving on a regular basis regardless of auto logout times.

**Visible register indicators** .....this is particularly relevant for schools where teachers are taking registers in the classroom. The registration screen can now display by a show of icons various indicators (e.g. SEN, PP, FSM etc.) next to the pupil names.

Administrators need to activate the icons they wish to display and the style of the icon preferred. For example, you may wish to display the Pupil Premium pupils, but not those with Safeguarding Alerts.

Go to **Modules > Attendance > Settings > Register Indicators tab > Edit** > select the indicators you wish to show on the registers and select the style preferred (as below) and click OK. These icons will be visible to all users in a school when activated. If class teachers display registers on whiteboards to pupils, then visible indicators may not be appropriate.
